



## *Disability Documentation Requirements*

New incoming students will first need to complete the Accessibility Team Registration Intake document. They **MUST** also provide one of the following documents listed below.

Returning students will need to have completed one of the following documents listed in the table below, to continue with an accommodation. Some returning students will already have one of these documents on file.

This is a guide and not an exhaustive list of possible diagnoses. A student **MUST** provide at least one of the following documents and it **MUST** include the list of recommended accommodations the student requires to be successful in their studies. Only items listed on the relevant documentation will be considered and not items self-identified on their Accessibility Office Intake form. As a note, information on the OSAP Disability Verification Form (DVF) is a supplementary document used to make accommodations but is in addition to one of the documents listed below.

<p><b>Learning Disabilities</b></p>	<ul style="list-style-type: none"> <li>• Psycho-Educational Assessment no older than 3 years if done before 18 with adult and post-secondary recommendations. If the assessment was done after age 18, no older than 5 years.</li> </ul>
<p><b>Chronic Health Problems:</b> Long-Covid, Chron’s, chronic pain, heart problems, Fibromyalgia, Post-Concussion Syndrome, Cancer treatments</p> <p>These can be permanent or prolonged disabilities</p>	<ul style="list-style-type: none"> <li>• <a href="#">Heritage Medical Disability Verification Form</a></li> </ul>



<b>Mental Health Impairment</b>	<ul style="list-style-type: none"><li>• <a href="#">Heritage Mental Health Disability Verification Form</a></li></ul>
<b>Acquired Brain Injury</b>	<ul style="list-style-type: none"><li>• <a href="#">Heritage Acquired Brain Injury Disability Verification Form</a></li></ul>
<b>English as a Second Language Student</b>	<ul style="list-style-type: none"><li>• Letter or email from the Dean with allowable recommendations</li></ul>

**NOTE:** Accommodations requiring memory aids during exams and tests require a psycho-education assessment that includes specific memory assessments completed. For more information, please contact the Accessibility office.
